### Extract from ADA University Library Information Resources' Use Policy and Procedures

#### Paragraph 4. User Privileges

#### 4.7. ADA University Partners and ADA University Foundation Donors

Up to 5 employees per partner company can benefit from on-site membership.

The number of online library membership is unlimited.

Library services for partners possessing the card include the following:

- On-site access to library physical collections (print books, serials, journals, newspapers, audiovisual materials);
- Access to e-books: Ebook Library and other online digital libraries, which include full-text e-book collections;
- Access to online databases that include full-text e-book and e-periodical collections;
- Reference and instructional support for academic research and writing, information literacy consultation;
- Borrowing and on-site use of headphones, pens, pencils, markers, rulers, flash drives, converters, USB drives and other stationery;
- Access to Library's facilities, as well as computer workstations, Internet access, group study rooms etc.

## Extract from ADA University Library External Visitors' Policy and Procedures

#### **Main Procedures**

#### Clause 3. Requirements and Request form.

- For online requests, the users are required to fill out the "<u>External Visitors' Request and</u> <u>Agreement Form</u>" and send their signed, scanned versions along with the e-copies of their national ID cards/passports and business ID card to circulationdesk@ada.edu.az email address;
- All above-mentioned documents should be submitted and all required fields of the "External Visitors' Request and Agreement Form" must be filled out carefully. Important Note: Incomplete applications will not be accepted.

## A number of conditions should be taken into consideration when visiting ADA Library:

- only registered members will be able to visit the Library (Open hours: <u>http://lib.ada.edu.az/en-US/Pages/Open\_Hours85d9.html?PageID=86</u>);
- 3rd booster dose of Covid-19 vaccine is required in order to enter the ADA campus;
- national ID card or passport should be shown to security staff when entering the campus;
- when in the Library building, all library resources (both print and electronic) will be available for on-site usage;
- registered ADA Library members will be able to use only Library building, and Student Center (C Building) for cafeteria;
- other campus buildings can be entered in case if you have scheduled appointment with ADA Faculty/Staff member.
